

Leadership Circle 2025 Annual Mission Delegation – Terms & Conditions

Please read the following carefully before accessing and/or participating in the Leadership Circle 2025 Annual Mission Delegation (defined below) organized by Start-Up Nation Central Ltd. (CC) (“**SNC**” or the “**Organizer**”). By clicking “I AGREE”, “ACCEPT”, “PAY NOW” or other similar button, or by paying for and/or participating in the Mission (defined below), you expressly acknowledge and agree to be bound by and comply with these Leadership Circle 2025 Annual Mission Delegation – Terms & Conditions (“**Terms**”, and the date of such acceptance, being the “**Effective Date**”).

SNC General Website Terms under the following link: <https://startupnationcentral.org/terms/> (“**SNC General Terms**”) shall be incorporated herein by reference. **These Terms relate only to the Mission** (defined below). In the event of any conflict between SNC General Terms and these Terms, these Terms shall govern with respect to the Mission.

1. Registration & Commitment Fee Payment

The commitment fee, method of payment and terms of payment for the Mission shall be set forth in the following link: <https://lp.startupnationcentral.org/product/lc-annual-mission/> (“**Payment Page**”) (collectively, the “**Fees**”). Fees are due at the commencement of the Term (defined below) and shall be paid by the Participant in advance on the Effective Date. Once payment is processed and confirmed, registration to the Mission is confirmed.

2. Cancellations & Refunds

The Fees are non-refundable, and are without any right of set-off, deduction or cancellation, except in accordance with the Israeli Consumer Protection Law, 5741-1981, and the regulations enacted thereunder. However, if the Participant is unable to take part in the Mission due to a Force Majeure Event (as defined in Section 9 below), and subject to providing the Organizer with prior written notice thereof, the Participant shall be entitled to a refund of the Fees.

3. The Mission

Organizer invites the Participant to participate in the Leadership Circle 2025 Annual Mission Delegation as specified under the following link: <https://lp.startupnationcentral.org/leadership-circle-annual-mission/> (“**Mission Description Page**”), as may be amended by Organizer from time to time (the “**Mission**”), and may provide the Participant with other Mission-related activities or services, as determined by the Organizer. For clarity, Participant’s Leadership Circle Program membership and payment of the Fees includes: local transportation, curated experiences, meals (Kosher style), entrance ticket to the SNX Summit and its opening gala event. However, the Participant is solely responsible for all other expenses during the Term, including without limitation, payment and arrangement for the flights, hotel accommodations, travel insurance, and any personal expenses (e.g., extra meals, transportation outside the Mission activities, transportation to and from designated set-off and return points, and any personal activities not included in the Mission itinerary, etc.).

4. Modifications

SNC reserves the right, at its sole discretion, to modify these Terms at any time. Such modification will become effective three (3) days after the revised Terms are posted at the following link: https://lp.startupnationcentral.org/media/Leadership-Circle-Annual-Mission-Terms-and-Conditions_FINAL.pdf and your continued participation in the Mission and any part of it thereafter means that you accept those modifications. Notwithstanding the foregoing, SNC may modify the Mission and/or any part thereof, including the Mission Description Page and itinerary effective immediately, at its sole discretion.

5. Term and Termination.

The term of these Terms shall begin on the Effective Date and shall continue until the completion of the Mission (November 7, 2025), unless earlier terminated in accordance with these Terms (“**Term**”). Without derogating from the foregoing, for Participants who take part in any post-Mission programming (such as the extended activities over Shabbat on November 8–9, 2025), these Terms shall continue to apply to such extended participation.

Organizer reserves the right to terminate these Terms and/or temporarily suspend the Participant’s participation or access to the Mission at its discretion, including if required by law or at the request of governmental entities. Upon termination or expiration of these Terms, the Organizer shall discontinue the Mission and Participant shall not be entitled to any compensation or to participate in the Mission. Any provisions intended to remain in effect after the termination or expiration of these Terms shall continue to apply and remain in full force.

6. Liability

The Organizer shall make its best efforts to meet the Participant's expectations, however it does not warrant that the Mission will meet Participant's requirements. For clarity, Organizer does not promise or guarantee any specific outcome, business relationship, or investment opportunity as a result of the Mission.

The Organizer is not responsible for personal injuries, property loss, or damages during the Mission. Without limiting from the foregoing and to the extent permitted by applicable law, the Organizer and its affiliates, as well as their respective employees and subcontractors, shall not be liable, whether in contract, tort, or otherwise, for any direct, indirect, special, or consequential damages, any loss or damage to business earnings, lost profits, or goodwill, suffered by any person, arising from or related to the Mission and/or these Terms, even if the Organizer has been advised of the possibility of such damages. In any event, the total cumulative liability of the Organizer, its affiliates, and their respective employees and subcontractors, under, arising out of, or relating to these Terms, shall not exceed the total amount actually paid by the Participant to the Organizer under these Terms.

7. Data Privacy & Use

The Participant agrees that SNC may disclose the information provided by the Participant or on its behalf, to SNC's respective partners, subcontractors, and other third parties as required for the purpose of facilitating the Mission. Any processing of personal information will be performed as specified under the privacy policy: <https://startupnationcentral.org/privacy/>.

8. Participant Obligations

During the Term, Participant shall provide SNC with all necessary documents and any other required assistance to facilitate the Mission and shall comply with all applicable laws, regulations, relevant authorities and any guidelines provided by SNC or anyone acting on its behalf from time to time.

9. Force Majeure

The Organizer shall not be liable for any loss, damage, failure or delay resulting from any event beyond its reasonable control, including but not limited to law or regulation, action or inaction of civil or military authority, acts of God, natural disasters, war, military operations, acts or threats of terrorism, strikes, pandemics, government restrictions, or other unforeseen events ("**Force Majeure Event**"). In the event of a Force Majeure Event, the Organizer reserves the right to reschedule, modify, or cancel the Mission.

10. Governing Law

These Terms shall be governed by and construed in accordance with the laws of the State of Israel. The courts in Tel Aviv-Jaffa shall have exclusive jurisdiction regarding any dispute arising hereunder.
